4. Incremental progress of Talcher fertilizer projects during October 2023.

(A). REVIVAL OF TALCHER UNIT:

Government of India has mandated revival of Talcher unit of M/s FCIL, located in Angul district, Odisha. Accordingly, a Joint Venture Company named Talcher Fertilizers Ltd. (TFL) has been incorporated for setting up coal gasification-based Ammonia urea plant of 12.7 LMTPA capacity, which is first of its kind in India. Foundation of the plant was laid by Hon'ble Prime Minister on 17th February, 2019. Equity of GAIL, RCF & CIL in TFL is 31.85% each and that of FCIL is 4.45%. The project activities are being regularly monitored by DoF. The overall progress of the TFL project is as under: -

a) Overall progress of Project upto September, 2023 : Incremental progress during October, 2023 51.03 %

Overall progress upto October, 2023 0.86 % 51.89 %

- 2. Following are the major activities and achievements during October month, 2023:-
 - 19 major equipment of Coal Gasification-purification section dispatched by M/s i. ZCM from China on 20.10.2023. ii.
- Erection of Boiler chimneys of two boilers have been completed. Prilling tower is erected up to 15 meters. iii.
- Contract awarded for flare stack system to M/s Air oils on 16.10.2023. iv.
- Preliminary work (Soil testing, site survey etc) of railway siding has started. ٧.
- Officials of TFL had a meeting with Principal Secretary-Industries, Govt of Odisha to discuss various issues related to clearances from NHAI, Railways & Irrigation Deptt. for 36" water pipeline corridor. Principal Secretary-Industries, has directed the concerned to expedite the process.
- The issue regarding exemption of stamp duty on sub leasing of land to FCIL on vi. the basis of a circular of 2013 has been taken up with Govt. of Odisha.
- The TFL's top management team's visited China on 18.10.2023 to sort out the vii. various issues with M/s Wuhan Engg Co. Ltd., (WECL).

As against total available budget B.E. of Rs. 179065.62 Crore for F.Y. 2023-24, expenditure on administration of fertilizer subsidy during October 2023 was 9162.47 Crore Crore). P&K: & Progressive Rs. expenditure during April 2023 to October 2023 was Rs. 1114.58 122975.63 crore (Urea: Rs. 79660.35 crore & P&K: Rs. 43315.28 crore) i.e. the approx. 68.68 % of the total allocation.
