

**Office Memorandum**

**Subject: Induction of SSP manufacturing unit of M/s Datta Agro Services Pvt. Ltd. located at Gat No. 139, Near Onkareshwar Temple, At. Bhokri, Post. Kerhale, Tal. Raver, Dist. Jalgaon, Maharashtra into the Nutrient Based Subsidy Policy for P&K fertilizers, w.e.f. 3.9.2011.**

The undersigned is directed to say that as per the policy guidelines on concession scheme/Nutrient Based Subsidy Policy for SSP, the Technical Audit and Inspection Cell of M/s Projects and Development India Ltd. (PDIL) made first time technical inspection of the SSP manufacturing unit of M/s Datta Agro Services Pvt. Ltd. located at Gat No. 139, Near Onkareshwar Temple, At. Bhokri, Post. Kerhale, Tal. Raver, Dist. Jalgaon, Maharashtra on 10.6.2010. PDIL submitted its report to Department of Fertilizers on 29.9.2010. PDIL reported that the unit had started its commercial production on 5.6.2009 and the unit is technically competent to manufacture 132000 MTs per annum of SSP of the standards laid down under the FCO. Further, the unit had produced 825.000 MTs. Of SSP on 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> June 2010 as trial production out of the RSMML Rock phosphate of 31.50% P<sub>2</sub>O<sub>5</sub>. It was reported by PDIL that the unit had applied to Maharashtra Pollution Control Board for consent to operate the plant, but the same had not been granted by the time of inspection on 10.6.2010. M/s Datta Agro Services Pvt. Ltd., vide its letter dated 5.9.2011 submitted a copy of the order dated 3.9.2011 issued by Maharashtra Pollution Control Board granting consent to operate valid upto 31.3.2014, to the above said unit under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 21 of the Air (Prevention & Control of Pollution) Act 1981 and Authorization/Renewal of Authorization under Rule 5 of the Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008. The Company also requested to Department of Fertilizers that they may be allowed to start its commercial production/sale of SSP with effect from 3.9.2011. The company further requested that they may be allowed to get payment of subsidy under the Nutrient Based Subsidy Policy on the sales of SSP for the quantity, which was produced by them as trial production during the above mentioned dates i.e. 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> June 2010.

2. The matter has been examined in light of all the above-mentioned facts and circumstances. Accordingly, it has been decided to induct the unit in to Nutrient Based Subsidy Policy w.e.f. 3.9.2011. The company has also been allowed to claim payment of subsidy on the sales of 825 MTs of SSP produced by it as trial production during the above said dates.
