OFFICE MEMORANDUM

Subject: Revision in professional fee to be claimed by M/s Project and Development India Limited (PDIL) and M/s FACT Engineering and Design Organisation (FEDO) in respect of inspection/audit of SSP/BRP units and analysis of rock phosphate/blending of rock phosphates etc - reg.

The undersigned is directed to state that the technical Audit and Inspection Cells of PDIL and FEDO have been conducting inspection of SSP units, analysing rock phosphates and blending of rock phosphates for their suitability for production of SSP, analysis of Egyptian rock phosphate for their contents etc under the NBS policy and claiming professional fee as decided by Govt from time to time. Both PDIL and FEDO had requested for revision in the fee for inspections/rock phosphate analysis etc. Keeping in view the escalation in the cost of travelling, material etc, the existing fee structure for various inspections and analysis is hereby revised with immediate effect as per details below:

S. No.	Description	Revised fee
1.	First time inspection of new units/ inspection for capacity upgradation/ setting up of GSSP plants	Rs.90,000 per inspection
2.	Audit inspection of SSP units	Rs.75,000 per inspection per SSP/BRP unit
3.	Random Sampling of Egyptian rock phosphate to know the contents	Rs.50,000 per sample for each shipment.
4.	Analysis of Rock phosphate/ blending of rock phosphates to find out feasibility of production of SSP/BRP	Rs.90,000 per analysis

2. It has also been decided to continue analysis of Egyptian rock phosphate imported by SSP units for another six months upto March 2014 and the fees for analysis in this regard shall henceforth be borne by the SSP units themselves. The fee towards first time inspection of new units/Inspection for capacity upgradation/ setting up of GSSP plants and analysis of Rock phosphate/ blending of rock phosphates to find out feasibility of production of SSP/BRP shall continue to be borne by the SSP/BRP units. The fee towards audit inspection of SSP units shall continue to be borne by Government.

3. It has also been decided that first time inspection of new units/Inspection for capacity upgradation/setting up of GSSP plants in the states namely, Andhra Pradesh, Tamil Nadu, Kerala, Maharashtra shall now be carried out by FEDO.

4. This issues with the concurrence of IFD vide diary No.3816/AS&FA dated 8.11.2013.


