GSR............. In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Department of Fertilizers, Deputy Commissioner (Port, Operations and Project) Recruitment Rules, 2017, except as respective things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Deputy Commissioner (Port, Operations & Project) in the Ministry of Chemicals and Fertilizers (Department of Fertilizers), namely:-

- 1. Short title and commencement (1) These rules may be called the Ministry of Chemicals and Fertilizers (Department of Fertilizers), Deputy Commissioner (Port, Operations & Project) Recruitment Rules, 2020
 - (2). They shall come into force on the date of their publication in the official Gazette.
- 2. Number of post, its classification and level in the pay matrix. The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in column (2) to (4) of the Schedule Annexed to these rules.
- 3. Method of recruitment, age limit, qualification etc. The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in the columns (5) to (13) of the said Schedule.

- 4. Disqualification. No person,-
 - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from operation of these rules.

- 5. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order, for the reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving. Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Note 2: The Departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

(Period of deputation(ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed

Four years. The Maximum age limit for appointment by deputation(ISTC) shall be not exceeding 56 years' as on the closing date of receipt of applications)
Note 3: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January, 2016 (The date from which the revised pay structure based on the seventh Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding level in the pay matrix extended based on the recommendations of the said pay commission.
