3. An EMD of Rs. 1000/- (Rupees One Thousand Only) should be deposited with the tender in the form of an Account Payee Bank Draft/Pay order from any nationalized bank in favour of Pay & Accounts Officer, Department of Fertilizers, payable at New Delhi.

4. **General Terms & Condition:-**

1. Bidders may inspect the items on the stipulate date and time.
2. The items shall be sold to the highest bidder. The bids are invited for the lot (i.e. all the items contained in the list of obsolete/condemnable/irreparable furniture items as detailed in Annexure "A") as a whole, and no bid would be accepted for any part of the same.
3. List of the items are given at Annexure "A"
4. The Earnest Money Deposit (EMD) of successful bidder shall be adjusted from the total payment.
5. The successful bidder has to make full balance payment after due adjustment of EMD in the form of Demand Draft in favour of Pay & Account Officer, Department of Fertilizers, Payable at New Delhi within three days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited. The EMD of unsuccessful bidders shall be returned within one Month after the acceptance of auction bid, without any interest.
6. The Successful bidder will be required to lift all the items from the disposal site within three days after the payment of the balance amount. On failure to do so this office shall have the right to forfeit the entire amount of the bidder. On their own cost, the successful bidder will also be required to make his own arrangement of transportation, labour etc. for lifting the auctioned items.
7. No items once disposed to the successful bidder shall be taken back by this Department on any condition whatsoever.
8. Quotation letter in the sealed envelope super subscribed ("TENDER FOR DISPOSAL OF OBSOLETE/CONDEMNABLE/IRREPAIRABLE ITEMS" - furniture, almirah & other miscellaneous items) should be addressed to **Sh. Debashish Halder, Joint Director, FICC, 8th Floor, Sewa Bhawan, New Delhi-110066.**
9. The Quotation must be deposited/dropped in Tender Box kept in place of Reception Officer, Sewa Bhawan, New Delhi 110066 on or before the due date and time otherwise it shall be liable to be rejected. The Tenders received after the due date and time due to any reason whatsoever shall not be considered.
10. The financial bid quoted amount should be given in both in figures and words. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the Tenderer. The figure quoted in words shall be deemed to be final in case of any discrepancy noted in the bid.
11. Deduction of applicable GST shall be indicated by this Department to the successful bidder. No representation shall be entertained by the successful bidder in this regard.

12. FICC, Department of Fertilizers reserves the right to accept or reject any/all quotations without stating reason whatsoever. No representation in this regard shall be entertained from any of the bidder.
13. Each page of tender document should be signed by the bidder(s).
14. Incomplete and unsigned bid is liable to be rejected. The bid is to be submitted for the entire lot, as mentioned in SI. No - 3 in the tender notice General Terms and Conditions.
15. Bidder must enclose copy of address proof (Voter I - Card/Adhaar Card/Driving License etc.) and Pan Card along with the bid.
16. An earnest Money Deposit (EMD) of Rs. 1000/- (One Thousand Only) must accompany the bid, without which the relevant bid shall summarily be rejected.
