#### 4. Incremental progress of Talcher fertilizer projects during May 2023.

### **REVIVAL OF TALCHER UNIT:**

Cabinet in its meeting held on 04.08.2011 approved revival of Talcher unit of FCIL through nomination basis by forming a Joint Venture of nominated PSUs by setting up gas-based fertilizer plants of 1.27 MMTPA capacity. Accordingly, a JV company was incorporated as Talcher Fertilizers Ltd. (TFL). Equity of GAIL, RCF & CIL in TFL is 31.85% each & FCIL's is 4.45 %. TFL plant is based on Coal Gasification Technology. The project activities are closely monitored by DoF through monthly review meetings held under the chairmanship of Secretary (Fertilizers).

## Progress of the TFL project is as under

a) Overall progress of Project upto April, 2023 : 44.36 %
b) Incremental progress during May, 2023 : 1.51 %
c) Overall progress upto May, 2023 : 45.87 %

# 5. Expenditure position:

As against total available budget B.E. of Rs. 179066.43 Crore for F.Y. 2023-24, expenditure on administration of fertilizer subsidy during May 2023 was Rs.9376.22 Crore (urea : Rs. 9265.98 Crore & P&K : Rs. 110.24 Crore). Progressive expenditure during April 2023 to May 2023 was 25606.43 crore i.e. the approx. 14.30 % of the total allocation.
