## Office Memorandum

Subject:

Reimbursement of losses occurred to fertilizer companies on account of buy back of fertilizer bonds by RBI.

The undersigned is directed to say that Government had agreed to reimburse 50% of losses incurred by fertilizer companies in buy back of bonds by RBI. The 50% of the total losses incurred by the fertilizer companies as communicated by FAI is Rs 890.94 crore. The 50% of the total losses incurred by the fertilizer companies as computed by Budget Division, Department of Economic Affairs in consultation with RBI and Middle Office is Rs.778.93 crore. The Budget Division of DoEA has directed to reconcile the figure of losses with RBI. Pending reconciliation, it has been decided to make partial payment to the extent of 70% of 50% of total losses on buy back of bonds by RBI in both the tranches as per the figures provided by DoEA. Accordingly, it has been decided to reimburse the losses to various fertilizers companies as per the amount mentioned in the attached statement.

Director (FA), DOF and Director (F&A), FICC (for indigenous urea) are requested to make payment to the concerned fertilizer companies as per the enclosed statement, based on the claims made by them duly vetted by auditors of the companies, as per the prescribed procedure.
