The undersigned is directed to invite a reference to para B (iv) of this Department O.M. of even number dated 23/07/2012, wherein it has been announced that special compensation for freight on account of secondary movement of all the P&K fertilizers (except SSP) shall be provided for difficult areas namely Himachal Pradesh, Uttarakhand, Sikkim, J&K, 7 N-E States and Andaman & Nicobar Islands.

2. Accordingly, the special compensation for freight on account of secondary movement of P&K fertilizers (except SSP) to the difficult areas shall be the excess of expenditure incurred as per the rates mentioned below above Rs. 300 PMT. The rates for secondary movement of P&K fertilizers (except SSP) w.e.f 1.4.2012 in various States shall be as under:
