**OFFICE MEMORANDUM**

**Subject:-Continuation of Technical Audit of SSP manufacturing Units, analysis of rock Phosphate/blending rock etc. by M/s Fact Engineering and Design Organization (FEDO).**

The undersigned is directed to refer to this Department O.M. of even number dated 16.7.2012 and 18.9.2012 (copies enclosed) wherein M/s FEDO was assigned the work relating to technical inspection of SSP units, testing of rock phosphate/blending rock etc. in respect of SSP units located in the state of Andhra Pradesh, Tamil Nadu, Maharashtra and Karnataka for a period of one w.e.f. 16.7.2012.

2. The proposal for extension of assignments of inspection work was considered in the Department and it has been decided that M/s FEDO will continue to do the assignments as stipulated in O.M. of even number dated 16.7.2012 in respect of SSP units located in the States of Andhra Pradesh, Tamil Nadu, Maharashtra and Karnataka, until further orders. It has since also been decided that the professional fee for analysis of Egyptian Rock Phosphate imported by SSP units will be borne by the particular SSP units.

3. As the request of M/s FEDO and M/s PDIL to revise the professional fee for the above said assignments is under consideration in the Department, M/s FEDO and M/s PDIL will claim the professional fee at existing rates till revised fee structure is finalized.

**OFFICE MEMORANDUM**

Subject: Technical Audit of SSP Manufacturing Units – Inclusion of FACT Engineering and Design Organisation (FEDO) in the Technical Audit & Inspection Cell (TAC).

The undersigned is directed to state that a Technical Audit & Inspection Cell (TAC) under the aegis of PDIL was constituted to look after the following works relating all SSP units:

- a) First Time technical audit/inspection of new SSP unit to ascertain technical competence of the unit to produce SSP as per FCO norms.
- b) Six-monthly audit/inspection of SSP units to ascertain whether the working of the units are as per tenets of concession scheme/NBS policy which includes purchase/consumption of Rock Phosphate, consumption of Sulphuric acid/ power etc., production of SSP, quality of SSP etc.,
- c) Evaluation/Testing of Rock Phosphate to ascertain suitability of rock phosphate as primary as well as blending rock for production of SSP as per FCO norms and subsequently facilitate the Department for notification of new rock phosphates and blending combinations for production of SSP.
- d) Random Collection and Testing of Rock and SSP from manufacturing units.
- e) Testing & Certification of Imported Rock Phosphate for evaluation of quality of Rock Phosphate especially from Egypt for manufacture of SSP as per FCO norms.
- f) Any other assignment as given by DOF from time to time.

3. As the work of monitoring of quality of rock phosphate, six monthly inspections of SSP units and certification of new rock phosphate/blending combinations has increased over a period of time the existing TAC under PDIL is finding difficult to finish the assigned work in time. Therefore, it has been decided to assign the work relating to (b) to (f) above in respect of the SSP Units located in Maharashtra, Andhra Pradesh and Tamil Nadu to FACT Engineering and Design Organisation (FEDO) on the existing terms and conditions of PDIL for a period of one year from the date of this letter. A list of SSP units under NBS in the above three states and the detailed terms and conditions are annexed.

3. Before starting the work, FEDO will get in touch with PDIL to get details regarding work accomplished by PDIL in respect of SSP units of these states and pending work to be completed in a year.

4. This issues with the approval of competent authority.


Subject: Technical Audit of SSP Manufacturing Units – Inclusion of FACT Engineering and Design Organisation (FEDO) in the Technical Audit & Inspection Cell (TAC).

The undersigned is directed to refer to this Department O.M. of even number dated 16<sup>th</sup> July 2012 regarding assignment of the work of inspection, testing of rock phosphate etc. of SSP units in the states of Andhra Pradesh, Tamil Nadu and Maharashtra to FACT Engineering and Design Organisation (FEDO) and to state that PDIL has requested for allocating the work of inspection etc of SSP Units in the State of Karnataka also to FEDO. This has been considered in the Department and the competent authority has decided to assign the work of inspection of the SSP Units in the State of Karnataka to FEDO on the existing terms and conditions.
