
Subject: Guidelines on Development of Market Development Assistance (MDA) for Promotion of Organic Fertilizers – Research & Development-reg.

The undersigned is directed to refer to the Guidelines of MDA for promotion of Organic Fertilizers – R&D dated 13.06.2024, and to convey the following amendments under the “**Payment Terms**”, as specified in Para 8 of the above-said Guidelines for the proposals relating to “**demonstration of FOM/LFOM etc.**”:

8	<p>i. 25% advance payment on award of contract/signing of MoU.</p> <p>ii. 15% payment after submission of first draft of evaluation, analysis, recommendations and report of invoice.</p> <p>iii. 15% payment after submission of second draft report incorporating all comments on the first draft report.</p> <p>iv. 20% payment after submission of final report incorporating all comments on draft report.</p> <p>v. Balance 25% after approval of the Report by PDIL and DoF</p>	<p>i. Release of Grant to be made before start of each season for projects related to promotion/demonstration of FOM/LFOM etc.</p> <p>ii. Subsequent release of Grant (on per season basis) will be made based on the utilization certificates of the previous release.</p> <p>iii. The Grant under CNA system will be released as per Master Circular issued by Ministry of Finance, Department of Expenditure vide their OM No. 3/(06)/PFMS/2023 dated 21.05.2024 on “Just-in-time” principle.</p>

2. The amended text of provisions under the ‘Payment Terms’ will only be applicable to proposals relating to “demonstration of FOM/LFOM etc. The existing text of provisions will remain unchanged for other proposals.
