OFFICE MEMORANDUM

Subject: Notification of Beneficiated Rock Phosphate produced by M/s APINDIA Biotech Pvt. Ltd., Meghnagar, Madhya Pradesh for production of SSP under NBS Policy.

The undersigned is directed to state that M/s APINDIA Biotech Pvt., which had established a Beneficiated Rock Phosphate (BRP) Plant (Unit-II) at Meghnagar, Madhya Pradesh for manufacture of BRP out of 18-20% P₂O₅ Low Grade Rock Phosphate (LGRP) of Madhya Pradesh State Mining Corporation Ltd., was technically got inspected through PDIL to ascertain as to whether the BRP produced by the said plant is capable of producing SSP as per the FCO norms. The PDIL in its report has intimated that BRP plant set up by the company is capable to process 120000 MTPA (400 MTPD) of 18-20% P₂O₅ LGRP of MPSMC to produce 60000 MTPA (200 MTPD) BRP containing 31% P₂O₅ (minimum). The PDIL has certified that the BRP produced by the company having 31% P₂O₅ (minimum) content and 87.87% conversion efficiency is suitable for production of SSP as per FCO norms with Acid to Rock ratio in the range of 0.60 to 0.65.

2. PDIL report has been examined and the Government has accepted the same. Accordingly, the BRP produced by M/s APINDIA Biotech Pvt. Ltd, Meghnagar, Madhya Pradesh as per the P₂O₅ content mentioned above is hereby notified provisionally for a period of six months from the date of issue of this letter.

3. The above approval is also subject to the condition that sale of BRP by the company shall be made only to SSP manufacturing units already included in the NBS Policy of this Department.

4. This issues with the approval of competent authority.
