

RPT: ALL COMPANIES HAVING MARKETING ARRANGEMENT WITH SSP MANUFACTURE FOR MOVEMENT/SALES OF SSP.

DEPARTMENT OF FERTILISERS WILL BE MONITORING THE MOVEMENT OF SINGLE SUPER PHOSPHATE (SSP) FERTILIZER WITH IMMEDIATE EFFECT IN FERTILIZER MONITORING SYSTEM (FMS) (.) YOU ARE ADVISED TO UPLOAD THE TENTATIVE SUPPLY PLAN OF SSP, STATE-WISE IN FMS BY 20TH OF EVERY MONTH FOR SUCCEEDING MONTH (FOR EXAMPLE THE SUPPLY PLAN FOR THE MONTH OF JUNE, 2012 WOULD BE UPLOAD BY 20TH MAY, 2012) (.) THE DOF WOULD MAKE NECESSARY CHANGES, IF ANY, IN ORDER TO SUPPLY SSP FERTILIZERS TO ANY STATE, IF REQUIRED (.) THE FINAL SUPPLY PLAN AS MODIFIED BY DOF WILL BE UPLOADING IN FMS BY 25TH OF THE MONTH (.) ALL ARE ADVISED TO COMPLY STRICTLY, FAILING WHICH THE SUBSIDY/CONCESSION ON SSP FERTILIZERS WILL NOT BE RELEASED WITH EFFECT FROM JUNE, 2012 (.) IN CASE OF ANY PROBLEM IN UPLOADING DATA IN FMS, YOU MAY CONTACT DIRECTOR OF ACCOUNTS, DOF (.) REGARDS (.)
