4. Revival of Gorakhpur & Sindri units of FCIL and Barauni Unit of HFCL

(a) CCEA in its meeting held on 01.08.2018 has approved the proposal of this Department for grant of Interest Free Loan equivalent to interest during construction component amounting Rs 1257.82 crore to fertilizer revival projects at Sindri, Gorakhpur and Barauni by Hindustan Urvarak and Rasayan Limited.

(b) The Union Cabinet in its meeting held on 09.08.2018 has approved Concession Agreements & Land Lease Agreements for the revival of Gorakhpur & Sindri units of Fertilizer Corporation of India Limited (FCIL) and Barauni unit of Hindustan Fertilizer Corporation Limited (HFCL) by Hindustan Urvarak & Rasayan Limited (HURL) and approval for providing land on lease.

5. Revival of Ramagundam Unit:

Ramagundam unit of FCIL is being revived on nomination basis by consortium of PSUs namely Engineers India Limited (EIL), National Fertilizers Limited (NFL) and FCIL by setting up a gas based fertilizer plant of 1.27 MMTPA capacity. As on 31st August, 2018, 88.8 % of physical progress of the project has been made.

6. Promotion of City Compost :

The sale of city compost by Fertilizer Marketing companies in August 2018 was about 19707.65 MT and cumulative sales of city compost during 2018-19 (April 2018 to August 2018) are about 67738.11 MT. The sale of city compost in bulk by compost manufacturers in August 2018 was about 14303.10 MT and cumulative sales of city compost in bulk during 2018-19 (April 2018 to August 2018) are about 38045.46 MT.

7. Subsidy Released

Subsidy released during 01.08.2018 to 30.08.2018 for indigenous urea and all other Fertilizers are Rs. 8007.76 Crore. Cumulative subsidy released from 01.04.2018 to 30.8.2018 for indigenous urea and other Fertilizers are Rs. 30204.41 Crore, which suggest that around 41% of the subsidy budget stands distributed in the first 5 months of F.Y. 2018-19 (from 01.04.2018 to 30.8.2018).

8. Submission of Cabinet Note:

(i) **RCF Land issues:** Final copies of the Cabinet Note were forwarded to the Cabinet Secretariat on 10.08.2018.

(iii) **FACT Restructuring:** A proposal for financial restructuring of FACT was circulated for inter-ministerial consultation. Comments from M/o Housing & Urban Affairs are awaited. Meanwhile, a presentation was held on 23.03.2018 in PMO to discuss the various scenarios with regard to financial restructuring of FACT. However, based on the comments during IMC from other ministries & discussion held in PMO, the draft Cabinet Note is being revised.

(iv) **MFL Restructuring:** Government of Tamilnadu vide its GO (Ms) No 79 dated 09.08.2018 has accorded No Objection Certificate for transfer of 70 acres of MFL land to Chennai Petroleum Corporation Ltd (CPCL). In view of this progress, the CCEA proposal for financial restructuring of MFL is under re-examination.
