Subject: Restriction of 1400KM imposed on movement of imported P&K fertilizers.


Sir/ Madam,

This has reference to this Department's fax of even number dated 29th October, 2012 regarding criss cross movement and restriction of 1400KM imposed on movement of imported and indigenous fertilizers. The Department of Fertilizers has decided to withdraw FAX order dated 29th October, 2012 (Copy enclosed) for imported P&K fertilizers only with effect from the date of issue of this letter.

2. It has also been decided that in case any company wants to move P&K Fertilizers (Imported) beyond 1400 KMs, the freight reimbursement will be restricted only upto 1400 KMs. The balance freight will have to be born by the respective companies.

3. All the manufacturers/importers are requested that they should strictly adhere to the port-wise imported movement plan and in case of any change in fertilizer movement plan as desired by the state governments or otherwise, prior approval from the Department of Fertilizer should be taken immediately.


