

The quotations should be addressed to the **Under Secretary (Admn.), Room No 205, D- wing, Shastri Bhawan , New Delhi** and given in room No. **203-A, D wing, shastri Bhawan at or before 12.00 PM on 29.05.14**. The quotations will be **opened on the 29.05.14 at 3.00 PM** in the presence of tenderers or their representatives who may wish to be present at the time.
- 4- Bid/offer not accompanied with the requisite D/D will not be considered/entertained abs-initio.
- 5- The successful bidder would be required to make full payment of the bid/offer amount by cash/Demand Draft positively before 12.00 Noon on 05.06.14.
