Dear Shri Bishnoi,

In continuation to the D.O. letter dated 27.5.2015 regarding the roll out of National Career Service (NCS), the NCS was dedicated to the nation by the Hon'ble PM on 20.07.2015. Since then, the portal has been successfully registering over 45,000 job seekers every day and more than 2.86 crore candidates are already registered. The core objective of the NCS project is to meet the career aspirations of youth by providing a common platform where they can access career related information, seek guidance and employment opportunities amongst other services. Improvements to the portal are being continuously made based on the feedback received to ensure its user friendliness.

2. The NCS aims to synergize the efforts being made by various government departments in enhancing employability and bringing more options to youth. As the Government plays a crucial role in generating direct and indirect employment through its various activities, it is requested that the following steps may kindly be taken :

(a) Posting of all vacancies on the NCS portal which could be for regular, contractual, part-time positions or for internships (paid/non-paid) etc. While the NCS will provide access to these opening to a wide candidate database, it will not enter into the recruitment process adopted by the various organisations.

(b) Encourage all training and skilling institutions (technical, vocational, educational etc.) under the State Government for posting of their courses for wider accessibility. The institutions could also be requested to ensure that the trainees are get registered on the NCS portal at the time of admission and completion of the course.

(c) Encourage other stakeholders like undertakings, corporations, societies, industry/corporates etc. to register and post their vacancies on the NCS portal.

3. You are requested to kindly get the action initiated on the above so that the NCS portal can cater to the employment needs of job seekers and other stakeholder. The NCS portal is hosted at the URL [www.ncs.gov.in](http://www.ncs.gov.in) supported by a help desk with a Toll Free number (1800-425-1514) to assist users in availing the various services under the NCS Project. The Ministry also looks forward to your suggestions for improving the delivery of services which may be sent on [feedback.dget@nic.in](mailto:feedback.dget@nic.in).
