Sub: Explanation for not importing any subsidized Fertilizer during last two years.

Sir/ Madam

I am directed to invite attention to Para 1 (iii) of this Department' OM No. 23011/06/2014-MPR dated 03.03.2015 (Copy enclosed), under which "If any new company after induction into the subsidy scheme fail to import any subsidized P&K fertilizer continuously for 2 years or any existing company fail to import/did not import any subsidized P&K fertilizer during two financial years, the registration of the importer may be deemed to be cancelled and for becoming eligible for subsidy the company shall be required to get re-registration in the subsidy scheme, for which it shall submit a request to the DOF with reasons for not importing the subsidy during two years/financial years". As per the records in this Department, it has been found that your company has not imported any subsidized fertilizers during the last two years.

2. **You are accordingly asked to explain as to why your registration as Importer under NBS should not be cancelled.** If no response is received **within the 15 days from the issuance of this letter,** your registration **will be cancelled** by this Department without further notice.



OFFICE MEMORANDUM

Subject: Eligibility of new importers registered under NBS Scheme for 'on account' subsidy payment - review of the existing guidelines.

The undersigned is directed to refer to this Department letter No.19011/11/2009-MPR dated 17th August 2009 regarding the general guidelines for induction of fertilizer companies as importers and payment of subsidy under the subsidy scheme, where it has been stipulated that importers notified under the Concession Scheme for P&K fertilizers who have been importing these fertilizers at least for the immediate preceding two years are eligible for 'on account' subsidy payment. It has been observed that many new importers after induction into the NBS Scheme either take considerable time to import or import very minimal quantity or do not import any of the subsidised P&K fertilizers. In order to ensure that only interested fertilizer companies serious enough to enter the business of fertilizers import, the following provisions with regard to eligibility of 'on account' payment of subsidy and continued registration under NBS Scheme have been made with immediate effect:

- i. A new importer is eligible for 'on account' subsidy payment on completion of two years **from the date of first import** (after induction into the NBS Scheme) at par with other P&K fertilizer companies subject to the condition that the company should have imported at least a minimum quantity of 30000 MT in two (2) years, out of which a minimum of 15000 MT in any one year and obtained Proforma-B certificate for the imported quantity from the State Government.
 - ii. The above provision will also be applicable to those importers who have been permitted to import P&K fertilizers in the preceding two years from the date of issuance of these revised guidelines.
 - iii. If any new company after induction into the subsidy scheme fail to import any subsidised P&K fertilizer continuously for 2 years or any existing company fail to import/did not import any subsidised P&K fertilizer during two financial years, the registration of the importer may be deemed to be cancelled and for becoming eligible for subsidy the company shall be required to get re-registration in the subsidy scheme, for which it shall submit a request to the DOF with reasons for not importing the subsidy during two years/financial years. The Department will consider such requests based on the facts and justification given by the company.
2. This has the approval of the competent authority.


