

OFFICE MEMORANDUM

**Subject: - Uniform Freight Subsidy for Phosphatic & Potassic (P&K) Fertilizers w.e.f. 1.4.2008 to 31.3.2010.**

The undersigned is directed to refer to this Department's letter No. 12012/2/2008-FPP dated 17.7.2008, 4.2.2009 and 17.3.2009 wherein uniform freight subsidy (UFS) policy was announced for all fertilizers including P&K fertilizers w.e.f. 1.4.2008. After implementation of NBS Policy for P&K fertilizers w.e.f. 1.4.2010, UFS Policy ceased to apply on P&K fertilizers.

2. The rates for reimbursement of freight on account of secondary movement and direct road movement for P&K fertilizers for the period w.e.f. 1.4.2008 to 31.3.2010 shall be as per the rates announced for urea vide letters No. 12012/9/2007-FPP dated 1.9.2011 and 21.5.2012.
3. No reimbursement on account of freight shall be made for SSP during the period.
4. This issues with the concurrence of IFD vide diary no 573 dated 19.07.2012 and approval of competent authority.
