Subject: Additional compensation for cost of captive Ammonia produced through Naphtha/FO/LSHS for a period of two years revision in the provision rates-regarding.

Madam/Sir,

In continuation of this Department letter of even number dated 22nd October 2010 with regard to additional compensation for cost of captive Ammonia produced through Naphtha/FO/LSHS for a period of two years w.e.f. 1st April 2010, I am directed to say that the Tariff Commission has been requested to undertake the study and provide its recommendations for finalizing the quantum of additional compensation. Tariff Commission has issued questionnaire for eliciting data for the study. The companies are requested to provide all relevant data to the Tariff Commission for the Study, if not provided already.

2. Pending the finalization of quantum of additional compensation based on the final recommendations of the Tariff Commission, Department of Fertilizers vide letter of even number dated 22nd October 2010 announced the amount of additional compensation for different grades w.e.f 1st April 2010 for 2010-11 provisionally. Subsequently, the companies citing increase in the cost of naphtha / FO/LSHS requested

the Department to revise the provisional compensation to enable them to meet their working capital requirements.

The matter has been examined in the Department and it has been decided to announce revised rates of additional compensation, provisionally subject to the final recommendations of the Tariff Commission, as follows:

- The revised provisional rates are applicable w.e.f 1st April 2010 for 2010-11 and w.e.f 1st April 2011 for 2011-12 (till the rates are finalized). The companies may claim their compensation from the Department accordingly. The companies are eligible to claim additional subsidy for the respective grades as per the provisional amounts mentioned above, in addition to the NBS.
- As the compensation would be for a maximum period of two years w.e.f 1st April 2010 to 31st March 2012, GNVFC, FACT and MFL, will have to convert to natural gas failing which they would be required to use imported Ammonia thereafter.
