Meeting was held today with HO Admn, PR dept and UC Estate on the above subject.

As requested by you, a tentative action plan for Swacchta Pakhwada 2017 (16-31st August 2017) including additional action points as per mail forwarded by DGM(DR) dated 21st July 2017, is given below:

* Seminar/ workshop on Plastic Waste Management is proposed to be conducted in association with CIPET (Central Institute of Plastics Engineering & Technology) and FACT Training Centre during this month.

* A limited quantity of bio-degradable waste generated in townships is converted to useful compost manure by the township residents themselves under the supervision of Estate dept. Bulk removal and disposal of bio-degradable waste is arranged by engaging garbage movers/ workers.

* Awareness programme will be arranged in Head Office and townships by way of posters, banners (cloth based), notices, leaflets, etc.

* As usual the pledge issued by DoF will be administered in offices. This will be followed by participation of officers and staff in a concerted cleaning effort in and around office premises.

* A competition will be held for the most innovative suggestion on the

subject of cleanliness and hygiene.

* Foursed attention will be initiated on developing a hygienic and clean working environment. Cleanliness drive will be organised at all divisions.

*This will include clearing of bushes/ overgrowth/ grass at road sides, medians, toilets, cleaning of vacant quarters/ buildings and premises, factory/ plant areas, cutting and removal of branches of trees standing by the side of public road and residential buildings

* Painting of interior/ exterior of office buildings wherever necessary. Sweeping, wet mopping of floors, cleaning office roof and walls to remove dust and cobwebs all offices, distributing free soaps and towels

* Display of banners on cleanliness and related matters in prominent places at plants and townships

* Collection of plastic waste, re-cycling of same in dumping yard, garbage such as domestic solid waste/ horticultural waste in the guarters/office area

- * Repair of damaged sanitary lines/ tank chambers
- * Planting of flowering plants in suitable areas in office compounds
- * Ensuring supply of purified drinking water to all employees
- * Disposal as per procedure of scrap furniture, unwanted office files/ documents, etc.
