Subject: Provisional Concession Rates and Sales Tax Rates per MT of urea on account of implementation of New Urea Policy – 2015 for existing 25 gas based urea manufacturing units.

In supersession to this department's letter of even number dated 3rd November, 2015 on the subject mentioned above, I am directed to say that it has been decided to revise the provisional concession rates and Sales Tax rates per MT of urea under the provisions of New Urea Policy – 2015 notified vide No. 12012/1/2015-FPP dated 25th May, 2015 for the month of June 2015 and continuing concession rates w.e.f. 1st July, 2015 based on pooled price of gas, in respect of 25 gas urea units as per details given below:

- Since the fixed cost for the urea units under modified NPS-III has not been notified, the existing fixed costs under NPS-III have been considered.
 - The guidelines for pooling of gas for fertilizer units dated 20th May, 2015 (read with OM dated 29th May, 2015) notified by Ministry of Petroleum & Natural Gas will also apply wherein the pool operator will issue debit/credit notes to the urea units for the difference between actual gas procurement cost of the unit and the pooled delivered cost.
2. The above concession rates and sales tax rates are provisional subject to audit and revision on account of any correction in data / workings and computation, if noticed later.
 3. You may prefer your claims on the basis of the revised concession price in the proforma prescribed by the FICC. Reduction in subsidy on account of downward revision of retention prices may be duly adjusted in the arrears bills or fresh bills to be preferred with the FICC and in case no payments are due from the Government, the amount be refunded to the Government by due date.

 5. This Department's letter of even number dated 3rd November, 2015 stands "withdrawn".
