Sir,

I am directed to refer to D.O. Letter No. 19011/26/2006-MPR-Vol-III) dated 30.10.2013 on the subject mentioned above and to state that the information/compliance in respect of registration of mixture/customised fertilizer manufacturers in the FMS and action taken against non-registration in the FMS, have not yet been received from your state.

- 2. You are, therefore, requested to expedite the requisite information and also issue instructions for registration of mixture/customised fertilizer manufacturers in the FMS immediately and commence uploading of data in the FMS for effective monitoring of supply of subsidised fertilizers to the mixture/customised fertilizer manufacturers in your state.
- 3. In case of non-compliance of the instructions or dealers selling/supplying subsidised fertilizers directly to mixture/customised fertilizer manufacturers, action such as cancellation of license of those dealers and mixture/customised fertilizer manufacturers may be taken, under intimation to this department, expeditiously.

Monitoring of subsidized fertilizers (Urea and P&K) used by

Mixture/ Customized fertilizer manufacturers.

Sir,

I am directed to state that Mixture/Customized fertilizer manufacturers have been allowed to source the subsidised Urea and P&K fertilizers directly from manufacturers/importers, only after their receipts in the districts as per this Department's letter No. 17-21/2001-MSHP/MPR dated 19.6.2013. In no case the mixture/customized fertilizers are allowed to source subsidized fertilizers from dealers/retailers.

- Since the use of subsidized fertilizers has a bearing on availability of subsidized fertilizers in every State, the Department has advised the State Governments and also the Mixture/Customized fertilizer manufacturers to get registered in the FMS and furnish information in the FMS. Despite these instructions, many Mixture/Customized fertilizer manufacturers have still not registered themselves in the FMS and continue to source the subsidised fertilizers from dealers/retailers. This is clearly in violation of the existing instructions in this matter and suggests that the dealers/retailers are either unaware of these instructions or are deliberately violating the same. Accordingly, the fertilizer companies (Urea & P&K fertilizers) are advised to ensure that their dealers/retailers should not sell any subsidised fertilizer to Mixture/Customized fertilizer manufacturers. In case dealers/retailers are found violating these instructions, action against such dealers/retailers should be taken by the companies, including cancellation of their dealership.
- 3. The fertilizer companies (Urea & P&K fertilizers) are also requested to furnish the month-wise details of subsidized fertilizers sold directly to the mixture/customized fertilizer manufacturers after their receipt in district during the period from April 2013 to October 2013 immediately by 20th December 2013.
