
2. Manufacturer and authorized dealers of LCD/Plasma are eligible to participate in the bid process. The firms may please quote the rates for all types of LCD/Plasma of 60 inches and above models and indicate their features against them to enable the Department to compare similar feature brands.

3. The firm should possess valid PAN No. and TIN No. The terms & conditions of the contract may be seen at **Annexure**. The interested bidders must furnish proof of his having been the Authorized Dealer of the manufacturer and also shall furnish attested copies of PAN Card and TIN Number. Quotations received without these documents shall be summarily rejected and no bidder shall have any right to make any representations against this even if his quotation happens to be the lowest.

Terms and conditions of the Contract

- i. The firm/agency should clearly mention whether it is authorized to sell/supply the LCD/Plasma of the make and specification mentioned in the tender notice. Authorization in this regard must be attached and duly signed by the manufacturer clearly stating as to who will be responsible for after sale service and maintenance of the machine during the period of warranty and service available in this regard, failing which bid will be rejected summarily. The Department of Fertilizer may verify the authenticity of the firm from the manufacturer at any time.
- ii. The supplier firm will clearly indicate the warranty period' of the product during which the firm will maintain the product free of cost.
- iii. The supplier must have valid PAN No ./VAT No./Sales Tax No./Service Tax No.
- iv. The supplier must supply the items within 7 days of the confirmed Supply order.
- v. In the event of any disputes arising out of the execution of contract/supply orders, the matter will be referred to Deputy Secretary (A&V) of this Department. Appeal against the decision of Deputy Secretary (A&V) will lie to the Joint Secretary (P&A) of this Department.
- vi. For judicial adjudication of the disputes, if any arising out of the Contract/Supply Orders will be subject to the jurisdiction of the Courts in Delhi only.
- vii. Incomplete bids in any manner shall not be accepted and are liable to be rejected.
- viii. The Department of Fertilizer reserves the right to reject any or all the bids in full or part or not to award the contract to the lowest bidder without assigning any reason therefore and giving any compensation. The decision of the Department of Fertilizer in this regard shall be final and binding on all.
