All the manufacturers/importers of P&K fertilizers and Urea manufacturers.

Subject: Use of subsidized fertilizers by manufacturers of customized/mixture fertilizer - reg.

The undersigned is directed to state that Customized/Mixture Fertilizer manufacturers have been allowed to source subsidized fertilizers directly from the manufacturers/importers after they reach in the district for manufacturing of customized/mixture fertilizers vide this Department letter No.23011/1/2010-MPR dated 4.3.2010. In order to monitor the source and quantity of subsidized fertilizers used by customized/mixture Units, directions were also issued to all customized/mixture units to get themselves registered in the Fertilizer Monitoring System (FMS) and thereafter to send reports of receipt of subsidized fertilizers through mFMS, like any other dealer of the fertilizer companies. It was also clarified that the customized/mixture fertilizer manufacturers should not be allowed to source subsidized fertilizers from dealers/retailers in the districts vide letter No.17-21/2001-MSHP/MPR dated 19.6.2012. Another letter of even number dated 30.10.2013 was also issued to all State Agriculture Secretaries for taking urgent necessary action on the issue. However, despite these instructions, many customized/mixture units have neither registered in the FMS nor uploading reports of receipt of subsidized fertilizers in the mFMS. As per the requirement in the FMS, the P&K fertilizer manufacturers/importers and Urea manufacturers are also required to enter the data relating to the quantity of subsidized fertilizers supplied to customized/mixture Units in FMS.

- 2. The customized/mixture fertilizer manufacturers are therefore, hereby informed to get their units registered in FMS and for uploading of the details of the subsidized fertilizers sourced, the name of manufacturer/importer and the quantity of customized/mixture fertilizes produced and sold from 01.04.2014 onwards within one month in the mFMS. Failure to do so will make the customized /mixture units ineligible for subsidized fertilizers.
- 3. In order to monitor the quantity of subsidized fertilizers supplied to customized /mixture units is used for manufacturing of state government approved customized /mixture fertilizers for agriculture purpose, the manufacturers/importers of P&K fertilizers and Urea manufacturers will now be eligible for supply of only those quantity of subsidized fertilizers, which are authorized by the State Agriculture Department and after their receipt in the district concerned, where the customized /mixture unit is located. The manufacturers/importers of P&K fertilizers and Urea manufacturers also required to ensure that the customized /mixture unit is registered in the FMS before supply of subsidized fertilizers.
- 4. The manufacturers/importers of P&K fertilizers and Urea manufacturers are also requested to furnish the details of subsidized fertilizers supplied to customized /mixture units w.e.f 1.4.2014 till date within 15 days.
